### 3.0 Changes to Garden Waste Collection

Mid Suffolk have carried out a review of their Garden Waste Collection Service. The service has grown over the years they have sometimes struggled on certain days during the summer to complete the rounds on the correct day.

The aim is to continuously improve the service for customers and accordingly have therefore reorganised collection rounds to cope with this extra growth.

The affected households should have received a letter last week informing them of the change.

The new collection day in Great Bricett will be Thursday (previously Monday). The changes will start from the week commencing Monday 6<sup>th</sup> February.

### 4.0 Dog and litter bin emptying service 2017/18

It has been decided not to increase the charges for 2017/18. The current costs are £30.00 per litter bin and £35.00 per dog bin. These prices are heavily subsidised by Mid Suffolk. The Council has a full time employee and a dedicated vehicle for this service. It is anticipated that charges will rise again in 2018/19.
